Pursuant to adjournment of March 3, 2005, Court reconvenes at 10:30 a.m. The People, represented by Lisa Gamoian, Chref Deputy District Attorney, and the defendant, Marcus Delon Wesson, with his counsel, Peter Jones, Chief Deputy Public Defender and Rafael Torres, Deputy Public Defender are present. All parties state they are ready to proceed.

The Court after reviewing the briefs submitted by the parties, the Court finds this is in the nature of a 402 hearing on the Evidence Code as well as under 780. The Court clears the courtroom for a confidential hearing.

The Court orders the transcript sealed pursuant to Rule of Court Section 243.1, Subdivision (d) as follows:

In this case the defendant is charged with nine (9) murders and multiple counts of rape and child abuse. There has been significant public interest and media coverage on an international scale.

Because of the seriousness of the charges in this matter, security issues related to the trial, concerns about securing a fair and impartial jury, and in order to provide a fair trial to the parties hereto: The Court finds as follows:

- (1) There is an overriding interest that overcomes the right of public access to the records being sealed;
- (2) These interests support sealing the records;
- (3) That a substantial probability exists that the overriding interest will be prejudiced if the record is not sealed;
  - (4) The sealing is narrowly tailored;
  - (5) No less restrictive means exist to achieve the overriding interest.

The Court adjourns at 10:50 p.m. until March 7, 2005 at 9:00 a.m.

The defendant, Marcus Delon Wesson, remains in the custody of the Sheriff of Fresno County.
