Status Reports must comply with the applicable code requirements. Notice of the status hearing, together with a copy of the Status Report shall be served on all necessary parties. Final Inventory and appraisal filed on 8/19/14 shows two different amounts \$1,425.50 and \$1,245.50. In addition the silver coins were not appraised by the probate referee as required.
