NEEDS/PROBLEMS/COMMENTS: CONTINUED FROM 10/09/13 Minute Order from 10/09/13 states: Stipulation and Order to Use Certified Shorthand Reporter is signed by the Court. The Court is informed that father is still living in the home. Parties agree to participate in an evaluation. The Court orders that visitation remain from 3:00pm to 6:00pm on the 2 nd and 4 th Saturday of every month. Telephone calls between mother and the children shall remain as previously set per agreement of the parties and order of the Court. In the event something arises and the telephone call(s) cannot be exercised as scheduled, parties are not to negotiate in good faith so the calls(s) can be rescheduled and time is not lost.

	TANIA CHEEK, mother, filed a petition for termination of the guardianship, which was denied on 07/24/13.	
	At hearing on 7-24-13, the Court referred the case to CPS to check on who is living in the home with the child and its safety. DSS Social Worker Keith Hodge was present in Court. Mr. Hodge was asked to submit a report to the Court and to the other parties. The Court ordered a marginal increase in visitation between the mother and the children and set this status hearing.

Petitioners last knew him to be in the Fresno County Jail, but he is no longer there. If diligence is not found, need proof of personal service at least 15 days before the hearing of Notice of Hearing with a copy of the Petition for Appointment of Guardian of the Person or Consent & Waiver of Notice for: - Mitch Arretche (father) 3. Need proof of service by mail at least 15 days before the hearing of Notice of Hearing with a copy of the Petition for Appointment of Guardian of the Person or Consent & Waiver of Notice or Declaration of Due Diligence for: a. Paternal grandparents b. Randy Davis* c. Angelina Rodriguez (if 12 or over)* d. Athena Rodriguez (if 12 or over)** *proof of service filed 12/11/13 is not marked indicating that a copy of the Petition was mailed along with the Notice of Hearing Note: Petitioners indicated that the children have Indian ancestry. The required Notice of Child Custody Proceeding for Indian Child (Form ICWA-030) was served on the necessary entities on 12/12/13. No response has been received from any of the tribes to which notice was sent. 60 days have elapsed since service was sent, therefore this petition may proceed pursuant to CA Rules of Court 7.1015(c)(9) which states if after a reasonable time following service of notice under the act—but in no event less than 60 days—no determinative response to the Notice of Child Custody Proceeding is received, the court may determine that the act does not apply to the proceeding unless further evidence of its applicability is later received.
