NEEDS/PROBLEMS/COMMENTS:

1. There are outstanding filing fees due the Court in the total amount of \$1,075 for various petitions and objection filed by Laura Hamilton and/or Carrie Jefferson (the decedent's two daughters) dating back to 2008. Because assets valued at \$245,700 are being distributed pursuant to this petition, payment of these outstanding fees is required:
 - \$320 Petition filed 5/8/08
 - \$320 Objection filed 6/17/08
 - \$435 Petition filed 6/19/14
2. Petitioner cites authority (*Marvin v. Marvin*) re distribution to Queen E. Jefferson, or her estate, but does not describe the cited authority at all. The Court may require clarification or further points and authorities regarding the designation of the property as community property, given the date of acquisition and the date of marriage.
3. This estate has been open since 2008 and this accounting shows no transactions whatsoever (receipts or disbursements). The Court may require clarification.
4. Petitioner requests distribution to the Estate of Queen E. Jefferson, but it does not appear that an estate has been opened or a personal representative appointed. Need clarification.
5. The attorney's office represented the former administrator from her appointment in 2008 until her death in 2013, but the estate was not closed timely during that time pursuant to Probate Code §12200. As a result, competing petitions and trial on appointment of a successor administrator occurred in 2014, for which the attorney now seeks extraordinary compensation. The Court may require clarification with reference to Probate Code §12205, which allows reduction in compensation for delay in administration that was not in the best interest of the estate.

Movant states this is a clear violation of the Court's order of 7/24/15. Additionally, Ali's safety continues to be jeopardized as Karen Clark continues to play a role in Ali's life, despite this Court's order that she have no visitation. See motion for details regarding an incident which suggests contact. Accordingly, Ms. Sabanovich respectfully requests that this Court compel Mr. Clark to resume therapy sessions for Ali on a consistent and ongoing basis, and that Mr. Clark not interfere with the Court's order prohibiting Karen Clark from contact with Ali.

Ms. Sabanovich further requests the Court clarify as to the "transportation" provision of the parties stipulation filed 1/7/16, which provides that for the first nine months, Ms. Sabanovich will provide all transportation, and thereafter, the parties will meet for all exchanges at the Baskin Robbins in Los Banos. As noted above, the stipulation was entered into in September 2015, and it was understood that the nine months would end in May 2016, with exchanges in Los Banos to begin in June 2016. Ms. Sabanovich requests clarification that the exchanges will begin in June.

See Declaration of Gary A. Hunt in support of motion.

For the foregoing reasons, Ms. Sabanovich respectfully requests this Court order compliance by Mr. Clark with its 7/24/15 order and clarification of the parties' stipulation.

NEEDS/PROBLEMS/COMMENTS:

1. This motion is not verified by Ms. Sabanovich pursuant to Probate Code §1020.
2. Probate Code §1602 states while a parent has custody, proceedings for modification of visitation orders made upon termination of a guardianship shall be determined in a proceeding under the Family Code. If no custody case exists in any county, the visitation order may be used as the basis for opening a case in the county in which the custodial parent resides.

Carl Clark, the custodial parent, and the minor reside in Salinas, which is Monterey County.

Need clarification re whether any family law case is currently existing in any other jurisdiction, and further authority re jurisdiction to make further orders re enforcement or clarification of this order in the Fresno Superior Court Probate Court. Ms. Sabanovich may be required to either seek joinder to an existing Family Law case, or open a new case in Monterey County, as applicable.

Note: Petitioner cites Probate Code §2630; however, this section pertains to jurisdiction re settling accounts on termination guardianship of the estate only and does not apply in this situation.
