<b>DOD: 8/24/2008</b>	<p><b>VICTORIA PUMAREJO</b> was appointed as Executor with full IAEA authority and without bond on 9/7/10.</p> <p>Letters issued on 9/7/10.</p> <p>Inventory and appraisal was due February 2011.</p> <p>First account or petition for final distribution was due December 2011.</p> <p><b>Creditor's Claim</b> of the Auditor Controller/Treasurer-Tax Collector was filed on 12/17/10 in the amount of \$17,863.50.</p> <p><b>Status Report filed on 3/4/14</b> states this is a single asset probate case. The only asset is real property. The real property has been maintained since the decedent's death by the decedent's son who continues to reside in the real property. The beneficiaries of the estate are decedent's children including the executor. When the estate was first opened the property was listed for sale. After an unsuccessful listing the property was taken off the market. The attorney became aware that the property was no longer being actively marketed in 2013. Executor has again taken steps to list the property. There has been one offer on the home so far, in an amount less than the executor was hoping to receive. It is hopeful that there will be additional offers prior to the status hearing on this matter.</p> <p>The estate is not ready for distribution and the executor believed that she had complied with all her initial duties, and that no further inventory or accounting was required. The attorney and the executor ask the court to excuse any inadvertent noncompliance. The terms of the Annuity (attached to the Declaration of Valene Madrid) indicate that the proceeds and interest may be withdrawn by the guardian. This does not appear appropriate. Per the Order of this Court, the funds must be placed into a blocked account from which withdrawals are only allowed by approval of the Court. The guardian may not have the ability to withdraw funds without first petitioning the court and obtaining an order to withdraw funds. Further, the annuity is not federally insured. The Court may require more information about the appropriateness of not having the funds deposited in a federally insured institution/account.</p>
