	<b>FREMONT BANK</b> , former Trustee, petitioned the court for approval of their first and final account.	<p><b>NEEDS/PROBLEMS/COMMENTS:</b></p> <p><b>Continued from 11/30/15. Minute order states</b> Counsel represents that the lien title will not be issued by the state until January.</p> <p>1. Need proof that the Trust is a lienholder on the vehicle or current written status report pursuant to Local Rule 7.5 which states in all matters set for status hearing verified status reports must be filed no later than 10 days before the hearing. Status Reports must comply with the applicable code requirements. 	<b>HERB THOMAS</b> is the current successor trustee.	
	The first and final account showed that Fremont Bank as Trustee for the Trust purchased a handicap equipped van for the beneficiary and distributed the van directly to the beneficiary.	
	<b>Minute Order dated 6/29/15 states</b> the court orders that the DMV is to be noticed that the Trust shall be the lienholder for the vehicle. Counsel is to submit a declaration verified by Herb Thomas.	
	<b>Former Status Report filed on 11/25/15</b> states Charities Pooled Trust (CPT) has been attempting to secure a lien on the vehicle, however it may not do so until the DMV issues and Electronic Lien Title (ELT). The DMV has informed CPT that the ELT will not be available until January 2016. Once the ELT is received they will be able to place CPT as a lienholder on the vehicle.
