Pursuant to this final accounting, it now appears that they will be receiving approx. \$115,000.00 in cash, accounts, and personal property. The Co-Administrators and/or their attorney have a duty to apply for increase of bond (Cal. Rules of Court 7.204). There is a status hearing set for 6-6-14 in 13CEPR01016 for the filing of the Inventory and Appraisal. The Court may review the Co-Administrators' bond at that time.</p>

It is unclear why they did not make the notice required. The Court may require further information and/or notice to the DHS.</p>

NEEDS/PROBLEMS/COMMENTS:

1. As previously noted, Probate Code §2201 provides that the proper county for commencement of a conservatorship proceeding is the county in which the proposed Conservatee resides. Petitioner states that although the proposed Conservatee resides in Monterey County, it is in the proposed conservatee's best interest that the conservatorship be established in Fresno County. The Court may require clarification regarding filing this petition here.

Note: Because the proposed Conservatee does not reside in Fresno County, an investigation has not yet been completed. As of 3-27-14, the reciprocal investigation from Monterey County Court Investigators has not been received pursuant to Probate Code §1826. Further Continuance may be necessary.

2. As previously noted, Petitioner requests dementia medication and placement powers; however, the Capacity Declaration filed 1-15-14 does not support this request. (The Dementia Attachment is signed by the doctor, but it is blank at #9a and 9b regarding capacity for dementia medication and placement consent.)

Therefore, need amended Capacity Declaration with completed Dementia Attachment.

3. As previously noted, Petitioner requests to either rent or sell the proposed conservatee's real property (former residence) in Monterey County; however, Petitioner does not state whether this has been discussed with the proposed Conservatee pursuant to Probate Code §2540. Need clarification. Note: Any sale would require Court confirmation pursuant to applicable code.
4. At hearing on 2-24-14, the Court granted Petitioner the authority to sell the real property and ordered bond of \$230,230.00. Bond has not been filed, and extended Letters have not issued. Need status update.

Note: If the petition is granted status hearings will be set as follows:

- Friday 5-16-14 for filing of Bond
- Friday 9-5-14 for filing of Inventory and Appraisal
- Friday 9-4-15 for filing the First Account

Pursuant to Local Rule 7.5 if the required documents are filed 10 days prior to the hearings on the matter the status hearing will come off calendar and no appearance will be required.
