CREEL</b> was appointed Conservator of the Person and Estate on 8/5/2011.</p> <p>Petitioner requests fees in connection with the representation of the Conservatee after being contacted by Adult Protective Services regarding an abrupt move of the conservatee from his personal residence to a care facility. As a result of the conservatee's abrupt move from his home and the concerns of other persons involved in his life Petitioner states she spent a great deal of time on this matter.</p> <p>Petitioner <b>asks that she be paid</b> from the conservatorship estate for <b>16.35 hours @ \$200.00 per hour for a total of \$3,270.00.</b></p> <p>Services are itemized by date and include review of documents, visits with client, and court appearances.</p> <p><b>Reply to Petition for Attorney Fees filed by Ronald P. Creel on 3/18/12</b> states he does not object to the attorney fees request by Ruth Lind. However he would like to reply to matters described in her petition. Mr. Creel states his father had advanced Frontal Lobe Alzheimer's disease. Both of his doctors on their last evaluation recommended that the conservatee should be placed into a secured residential lock-down facility. The reply describes incidents where the conservatee, while living in his own home, would run away from his caretakers, was combative with the caretakers and on at least one occasion where the police had to be called.
