	<b>KIMBERLY ANN BRYANT</b> , Maternal Grandmother, was appointed Guardian of the Estate on 11/10/15 without bond, with funds to be held in a blocked account.	<p><b>NEEDS/PROBLEMS/COMMENTS:</b></p> <p><b>Minute Order 2/23/16: Michelle Angeles</b> represents that the minor's comp hearing is set for tomorrow and pending approval the funds will then be released.</p> <p><b>1. Need Receipt and Acknowledgment of Order for the Deposit of Money Into Blocked Account (MC-356) or current written status report per Local Rule 7.5.</b></p>
	At the hearing on 11/10/15, the Court signed an Order to Deposit Money into Blocked Account and set this status hearing for the filing of the receipt for blocked account.	
	<b>Status Report filed 1/25/16 states</b> that on 12/17/15, Farmer, Case & Fedor, the attorneys for the insurance carrier involved in the settlement, sent the Petition to Approve Compromise of Disputed Claim of Minor for filing with the Court. It was filed on 12/28/15, and set for hearing on 2/24/16 in Dept. 403. An earlier hearing date could not be obtained.	
	The settlement checks cannot be issued and the funds cannot be deposited until the Court approves the compromise. As such, the Guardian will not be able to file the receipt by the hearing date of 2/23/16.
