**NEEDS/PROBLEMS/COMMENTS (cont):**

8. Petition states the decedent's 1997 Buick was distributed to Kristina. Property of the estate cannot be distributed prior to creditor's being satisfied.
9. Petition states the "H" Street property was deeded to the personal representative in 2005. There is no "H" Street property listed on the inventory and appraisal. Need clarification.
10. Order does not comply with Local Rule 7.6.1.

**Petition states** all other beneficiaries have filed waivers of accounting of administrator and acceptance of \$10,000 as their full beneficial interest in the estate on 6/6/11. Because of the EDD lien the proceeds could not be distributed from escrow. All the funds, except administration and attorney fees, had to be paid to the mortgage on the "J" Street property, or the EDD would not allow the partial release of the lien. Since there was no money remaining after the payment of title fees, costs, attorney fees and property taxes, the Personal Representative took \$20,000 from her own retirement funds and paid all other beneficiaries \$5,000.00 each. All other beneficiaries have signed an assignment of their share of the "J" Street property to the petitioner. Petitioner has used this property as collateral to acquire enough money to pay off the "I" Street property's mortgage, back property taxes, and other debts of the decedent. Petitioner is still making payments on these loans.

The "H" Street property was deeded to the personal representative in 2005 and used as collateral for loans to pay back taxes and mortgage payments on the "I" Street property. The decedent's portion of the "I" Street property was sold in July 2012 and the proceeds were applied to the mortgage on the "H" Street property. There is still an outstanding balance on the "H" Street property that is being paid in full by the personal representative [who now holds title to the property].

Petitioners state that the mother failed to disclose to the family court that she is currently residing with a registered sex offender, George Brock, who was convicted of two separate offenses against children in 1985 and 2000. Petitioners state that the mother often leaves Samantha alone with Brock and Samantha has expressed that she is uncomfortable around him. Petitioners state that the mother often sends Samantha to stay with her Father (in violation of the courts April 2012 order) who has a felony conviction for child abuse and is currently in a volatile relationship and Samantha has witnessed domestic violence. Petitioners also allege that both parents ignore Samantha's health, as she has had an ear infection for over a month and neither parent has sought treatment for her. Petitioners state that prior to obtaining custody of Samantha in April, the mother hadn't seen Samantha for about 5 years. Petitioners state that they have raised Samantha the majority of her life.

**Objection to Petition for Appointment of Guardian filed 02/11/13 by Tonya Boggs, mother, states:** that she objects to Claude and Charee Boggs being appointed as guardian of Samantha and further states that Samantha does not want to live with them. She states that they have a history of not bringing Samantha to court and it is likely that they will not bring her to court. Further Objector states that the Petitioners have intimidated Samantha in the past and instructed her to not "say a word". She further states that they have hidden Samantha in Squaw Valley in the past. Objector states that the Boggs' Petition is filled with lies. She states that Samantha has been living with Patricia Reagan for the past 10 months and that Petitioners knew where Samantha was the whole time. Objector states that the Petitioners are after Samantha's social security money. Objector states that Samantha's best interests are met in the care of Patricia Reagan. Ms. Reagan is a nurse and has the financial means to provide for Samantha and also is well intentioned and provides Samantha with the love and attention she needs. At Ms. Reagan's house, Samantha has her own room and is happy. Objector states that it is her strong desire that Samantha remain in Ms. Reagan's care. Objector also attaches a letter from Samantha that outlines many reasons why she does not want to live with Claude and Charee Boggs.

**Objection to Petition for Appointment of Guardian filed 02/11/13 by Randy Boggs, father, states:** he objects to the appointment of Claude and Charee Boggs as guardians of Samantha. He states that his parents are not seeking guardianship because they are concerned for Samantha's well-being, but rather are seeking guardianship for financial gain. He states that he is aware that their roommate recently moved out and they need to find a way to make up the difference. He further alleges that the Petitioners have used his identity to rent an apartment and purchase a car without his knowledge. He further states that the Petitioners do not give Samantha the love and care she deserves and states that he has personally witnessed them yelling at her, putting her down, and forcing her to do chores they should be responsible for. He also states that they have failed at teaching her hygiene because they do not have good hygiene themselves. Objector states that the Petitioners lied in the Petition by say that he pushed his father down the stairs. He states that this is not true. Mr. Boggs further states that it would be in Samantha's best interest that Patricia Reagan be appointed her guardian. He states that Samantha has flourished under Ms. Reagan's care. Ms. Reagan has enrolled her in a school that meets her needs, she attends a youth group, she has had her first birthday party and first sleep overs. He states there is no better place for Samantha at this time than with Ms. Reagan.

It is alleged that the paternal grandparents home is dirty and that CPS had been called on them when Samantha lived with them previously. Petitioner states that CPS intervention is what led her to file for and obtain custody of Samantha in April 2012 and Petitioner believes that CPS is likely to get involved again if Samantha is returned to the Boggs' care. Petitioner states that Samantha has stated that the paternal grandparents abused her physically, emotionally, and verbally. Petitioner further states that Samantha was neglected by the paternal grandparents by being made to sleep on the floor, not providing clean clothes and showers. He seeks guardianship of Jorge Eduardo Zaragoza so that he can raise him in a family environment that will allow their relationship to continue. He will continue to provide support, education, medical services, and care for the minor.</p> <p><b>Declaration filed 3-19-13 by Guardian Maria Zaragoza states</b> the children whose mother is deceased, including Jorge Eduardo Zaragoza, have lived in her home for about five years, including with their mother when she was alive. The maternal grandmother also lives in the home. Jorge's father has not been in his life until recently. Prior to the mother passing away, Petitioner refused to recognize Jorge Eduardo Zaragoza as his child. On several occasions, Ms. Zaragoza tried to show him pictures of his son, but he refused to look. The minor does not want to live with his father and new family as he is not familiar with them and is not used to them. Jorge and his siblings recently lost their mother and now show signs of being terrified with the idea of losing each other. The older children have expressed fear that they will lose their brother Jorge since they became aware of this proceeding. **Guardian states (Continued):** The guardian is concerned that Petitioner wants to remove Jorge from the only family and home that he has ever known, and also change his name, and that if his father takes him away from his family now, it will make things worse, not better. The guardian states she tried to explain this to Petitioner, but he insisted that the minor needs to be with him. He does not appear to be concerned about what the minor wants or how he would feel if he were taken away from his family and siblings after the loss of his mother.

Guardian states that in her opinion, the Court should reduce the visitation, because the minor does not appear to be adjusting well. On or about 1-17-13, the parties had a four-way conference and at the meeting, the guardian realized that Petitioner is not focusing on the best interest of the child because he does not realize that the child does not want to leave his family.

Guardian states she would agree to revisit the visitation schedule as long as the minor shows signs of being accustomed to change and his new family. However, she is concerned about Petitioner permanently taking the child as he believes the child is young and will eventually get used to his new "real" family and forget how much he is used to his siblings he is now with. Petitioner does not care about the siblings, which is disturbing, because they care about their brother.

Guardian states she is concerned for the child every time he leaves, as he cries and hesitates to visit the father's home. The guardian asks the Court for the child to stay in her home and not be separated from his siblings.
