DOD: 6-2-03	<p>CHARLES DUANE MARTIN, son and successor administrator is Petitioner.</p> <p>On 12-6-12, this Court granted the administrator’s Ex Parte Application for Order to Show Cause Why Maria Martin should not be held in Contempt and Sanctioned for Failure to Abide by the Court’s Order of 9-29-11.</p> <p><i>[The 9-29-11 Court Order removed Maria Martin as the estate administrator and ordered her to turn over control of all estate property to Charles Duane Martin, appointed as successor administrator, and granted Mr. Martin’s petition for probate.]</i></p> <p>Minute Order from 2-17-12 (hearing on OSC Re: Contempt): Ricardo Cristobal is sworn as the Spanish language interpreter. Attorney Ramseyer and Charles Duane Martin appearing by Court Call. The Judge has ability to defer the contempt citation and the action on it until the closing of the case. The 1930 Model A vehicle and the 1954 Packard are to be delivered to the Folsom real property. There will be appropriate pictures taken of the delivery and condition. There are a total of three vehicles with the old green Packard already on the premises. Maria Martin is allowed to use the Dodge Ram truck as long as she is licensed, with no unlicensed driver operating the vehicle, and with at least the legal limits of liability insurance, until ownership is determined. Maria Martin is not to sell, encumber, or otherwise do anything with the title pending further order of this court. Whoever takes the pictures of the cars on Sunday will examine the garage and see if the John Deere lawnmower is there. Maria Martin is to be at the residence between 10:00 a.m. and 12:00 p.m. on Sunday, February 19, 2012. The medals, ribbons and flag will be delivered to Mr. Kharazi's office. Mr. Kharazi informs the court that the bonding company has been put on notice. If the bonding company is not on board or if they cannot participate the Court may want to move that date and vacate the trial date. Mr. Kharazi will notify the court by Friday, 3-9-12 if he does not hear from the bonding company to set new dates. OVERTON was appointed Administrator without bond on 5/25/10 and Letters issued.</p> <p>I & A was filed on 12/22/11 showing the estate valued at \$510,000.00</p> <p>First Account or Petition for Final Distribution was due June 2011.</p> <p>Status Report filed on 4/2/12 states the primary asset of the estate is decedent's 80% interest in an apartment building in Clovis. Owen Overton owns the other 20% of this asset. The apartment was listed for sale shortly after letters issued for \$735,000.00. However, in June 2010 all sales activities stopped because the apartment building suffered substantial damage the fire. There was a dispute between the insurance company and the adjuster regarding the cost of repairs, and this delayed the process of even beginning repairs until March, 2011. Repairs were commenced and completed in approximately December 2011. DOD: 10/29/11	<p>CAROLE TOPHAM PITTS, Petitioner, was appointed Executor without bond on 02/15/12 and Letters were issued on 02/16/12.</p> <p>Petitioner states:</p> <ol style="list-style-type: none"> During their lifetime, Stanley A. Topham and Lurine S. Topham executed THE STANLEY A. TOPHAM FAMILY TRUST AGREEMENT (the "Trust"), which is dated 11/27/90. Following the death of Stanley A. Topham, the trust assets were allocated to a SURVIVOR'S TRUST, a MARITAL TRUST, and an EXEMPTION TRUST. Pursuant to the terms of Trust, Decedent, as surviving Trustor, retained a general power of appointment over the assets of the SURVIVOR'S TRUST and a limited power of appointment over the assets of the MARITAL TRUST and the EXEMPTION TRUST. Decedent exercised her powers of appointment over all three sub-trusts in her Will dated 11/20/08. The sole reason for submitting Decedent's will to probate was to exercise her powers of appointment. At the time of her death, Decedent's estate existed entirely of assets of THE STANLEY A. TOPHAM FAMILY SURVIVOR'S TRUST, MARITAL TRUST, and EXEMPTION TRUST. There are no other assets in her estate subject to the jurisdiction of this Court. All beneficiaries of the Decedent have survived her and Pursuant to the terms of the Trust, Carole Topham Pitts shall serve and has accepted the office of sole successor trustee.
