To DHS: \$2,970.48, with the first \$492,548.94 of any other thereafter discovered property until the claim is satisfied in full. Thereafter, any property not now known to be distributed $\frac{1}{4}$ shares to the heirs, Patricia Kiefer, William Martin Shiba, Kristine Shiba, and Virginia Young.

NEEDS/PROBLEMS/COMMENTS: The following issue remains noted:

1. **As previously noted, the disbursements schedule includes payments related to real property and trust matters, but this estate does not contain real property. Declaration filed 8/15/15 by Attorney Hiyama states the real property is held in the Shiba Family Trust, and because the trust did not have any accounts, maintenance expenses were paid from the estate. Given the fact that a creditor's claim remains outstanding, it appears detrimental to the estate creditor that funds were expended on real property that is not an asset of the estate.**

In connection with the previous version of this account, a status report was filed 2/26/16 that stated settlement had been reached with DHS and the office of the Attorney General was preparing a settlement agreement. However, this amended petition makes no mention whatsoever of any settlement or agreement. The Court may require clarification or reimbursement to the estate for all expenses paid on behalf of the trust.
