Cont. from	<p>Petitioner states that on October 10, 2011, the Conservator filed a petition for reimbursement for deposits made and costs incurred because of his misunderstanding of the contents of the order appointing him which required him to get Court approval before he moved the Conservatee from Sunrise. The Conservator then filed an amended petition no only asking for reimbursement, but also to remove Petitioner as Court appointed counsel for the Conservatee. Because the Petitioner took the actions of sending out a change of address, hiring another attorney, and making a deposit with a care facility without consulting his attorney, Petitioner opposed the requested reimbursement. A settlement conference was held that resulted in the Conservator receiving the requested reimbursement and that Petitioner was to remain as the Court appointed counsel for the Conservatee.</p> <p>Petitioner <b>asks that she be paid</b> from the conservatorship estate for <b>18.45 hours @ \$200/hr., plus a filing fee of \$435.00 for a total fee request of \$3,985.00.</b></p> <p>Services are itemized by date and include review of documents, preparation of documents, attendance at hearings and settlement conference, and telephone conferences with family of Conservatee.</p>

Petitioner filed another declaration of due diligence for the mother on 4-8-13 that indicates she checked with her probation dept., and last known employer. The last contact with the mother was a phone call in which the mother called her home and had a friend curse out Petitioner. She refused to provide an address other than a PO Box.  If diligence is not found, the Court may require continuance for service of Notice of Hearing pursuant to Probate Code §1511.  2. Notice was dispensed to the father (unknown) at hearing on 3-5-13.
