Order to Show Cause RE: Failure to Appear and Failure to File the Inventory and Appraisal

<b>DOD: 4-14-14</b>		<p><b>RAYNETTE GRANT</b>, Sister, was appointed Executor with Full IAEA with bond of \$60,000.00 on 9-25-14.</p> <p>Bond was filed 10-2-14 and Letters issued 10-16-14.</p> <p>At the hearing on 9-25-14, the Court set status hearing for the filing of the Inventory and Appraisal for 1-28-15.</p> <p>On 1-28-15, there were no appearances. The Court set this OSC Re Failure to Appear and Failure to file the Inventory and Appraisal and ordered both the attorney and the executor to be personally present in Court on 2-11-15.</p> <p>Final I&amp;A was filed 2-5-15 and indicates a total estate value of \$113,395.69 including \$2,486.19 cash, various vehicles and equipment, and a 40% undivided interest in real property.</p> <p><b>Status Report by Attorney filed 3-20-15 states</b> there was an inadvertent error in that the hearing dates of 1-28-15 and 2-1-15 were not posted on his calendar which resulted in his failure to appear. The Inventory and Appraisal of the estate has been filed and there was an assumption that the filing of the I&amp;A removed the hearing from the court calendar. The estate is not in a condition to be closed; there are not yet sufficient funds available for payment of the decedent's debts.
