Notice of Hearing filed 3-15-12 includes service on Graciela Llamas, who filed a Request for Special Notice on 10-2-08; however, a copy of the petition was not included. Probate Code §1252 requires that a copy of the Petition be served with the Notice of Hearing at least 15 days prior to the hearing on the person named in the Request for Special Notice. Therefore, unless the Court dispenses with the notice, or notice is waived by Ms. Llamas, further service <i>including the petition</i> may be required. 2. Examiner notes that Probate Code §§ 3610 and 3611(e) allow funds under \$5,000.00 from a judgment belonging to a minor or person with a disability to be paid pursuant to §3400. §3400 allows a parent to receive funds for a minor, but does not specifically refer to persons with a disability as mentioned in §3610. Petitioner states Angelica Rivera (disabled heir) is cared for by her sister, Ida Perez. Therefore, the Court may require clarification as to how Angelica's share is to be paid – i.e., directly to her, or to Ms. Perez. 3. Need order.
