3. This hearing was continued to 5-17-12 at 9:00 am. The Citation filed 5-10-12 indicates the trial time of 5-17-12 at 1:30 pm, which is the trial that is currently set for the other competing petitions and additional petition filed by Andrew Bosniak.

In addition, the Citation filed 5-10-12 indicates personal service on Proposed Conservatee Lucy Bosniak on 5-4-12, which is 13 days prior to the hearing, rather than 15 days as required by Probate Code §1824.

Therefore, the Court may require amended notice and additional time.

4. Need Capacity Declaration.

Note: Original Petitioner Andrew Bosniak filed a faxed copy of a capacity declaration on 1-6-12 supporting his request for medical consent powers; however, an original has not been filed.

5. Need bond of \$56,100.00 (includes cost of recovery per Probate Code §2320(c)(4) and Cal. Rules of Court 7.207).
