LESHER</b>, Sister, was appointed Executor with Full IAEA without bond and Letters issued on 3/20/14.</p> <p>At the hearing on 3/20/14, the Court set this status hearing re: Filing of the First Account or Petition for Final Distribution.</p> <p>Inventory and Appraisal filed 9/23/14 reflects a total estate value of \$3,660,626.66 consisting for the most part of various real property.</p> <p><b>Report of Status of Administration filed 5/7/15 states</b> the estate is not in a condition to close at this time because the estate lacks sufficient funds to pay administration expenses. The City of Fresno is negotiating with the estate for the acquisition of permanent and temporary construction easements for the construction of an underground pipeline to be located on the estate's property in Fresno County. It is anticipated that these negotiations will be completed within the next six months and the sale of the easement rights will generate enough cash to pay administration expenses.
