She made several attempts to prepare the documents herself with the assistance of a paralegal, but was unsuccessful in her efforts to provide the necessary information in the necessary form. The First Account was intended to cover the period of April 2013 to May 2014; however, while the conservator struggled to complete the first account, another year has passed. Additionally, the Conservatee passed away in February 2015. Therefore, it is Ms. Amador's intention to do an Amended First and Final Account and Report covering the entirety of the conservatorship period, as well as the necessary work to include an appropriate petition for distribution of the small remaining conservatorship estate. Ms. Amador has completed most of the necessary work and hopes to file it prior to the hearing on 5/27/15. Ms. Amador wishes to alert the court that the conservator was acting without the assistance of counsel and did not understand the requirement to create a conservatorship account and have all income and disbursements pass through that account only. However, she maintained fairly accurate records and can demonstrate what income was received by the Conservatee and how it was spent in almost all instances. Schedule C of the amended account indicates that the conservatorship estate bank account was closed and the amount remaining was delivered to beneficiaries; however, no petition for distribution was previously approved by the Court.
