Additionally, the Conservatee passed away in February 2015. Therefore, it is Ms. Amador's intention to do an Amended First and Final Account and Report covering the entirety of the conservatorship period, as well as the necessary work to include an appropriate petition for distribution of the small remaining conservatorship estate. Ms. Amador has completed most of the necessary work and hopes to file it prior to the hearing on 5/27/15. Ms. Amador wishes to alert the court that the conservator was acting without the assistance of counsel and did not understand the requirement to create a conservatorship account and have all income and disbursements pass through that account only. However, she maintained fairly accurate records and can demonstrate what income was received by the Conservatee and how it was spent in almost all instances. The attorney will do her best to document all receipts and disbursements.

- 1) He paid, from conservatee's funds, a total of \$956.38 to the Law Office of Mina L. Ramirez and agrees to reimburse the conservatorship estate this amount.
- 2) When Merced School Employees Federal Credit Union was notified of conservatee's death, the credit union automatically closed his bank account and issued checks to the named beneficiaries, as "pay-on-death" payees. Petitioner and his sister were the named beneficiaries.
- 3) Presently, the estate's real property is in foreclosure and is scheduled for a public sale in July 2015. The property appraised for \$175,000.00. There is approximately \$167,000.00 owed on the first mortgage, and \$17,000.00 on the line of equity that the conservatee owes. Petitioner seeks the court's authority to sell the house for either the appraised value or as a short sale.
