**Third Amended First and Final Account and Report of Conservator; Petition for Its Settlement; for Attorney Fees; and Discharge or Conservator of the Estate**

<b>DOD: 04/17/13</b>	<b>KATINA SAPIEN LOZANO PAULEY,</b> Conservator, is Petitioner.	<p><b>NEEDS/PROBLEMS/COMMENTS:</b></p> <p>1. It appears there is a miscalculation of the funds remaining in the attorney trust account as stated in the petition at paragraph 18. Examiner calculates the balance remaining after payment of the approved attorney's fees to be \$1,922.00 rather than \$1,442.00.</p> <p><b>Note:</b> Petitioner states that additional funds in the amount of \$8,189.84 (refund from Golden Living Center) and \$40.00 (refund from Aetna) were also deposited into the Joann Sanoian client trust account. Therefore, examiner calculates there should be a balance of \$10,151.84 (exclusive of any accrued interest) of conservatorship assets currently in the Sanoian client trust account. The Petition (and Order) seek authorization to withdraw funds from various conservatorship accounts to pay the requested attorney fees, however it appears that there are sufficient funds already in the trust account to pay the fees. Further, after payment of the requested \$7,295.00 in attorney's fees (if approved), there should be a balance of \$2,856.84 to be refunded to the conservatorship estate. It is noted that Schedule E – Property on Hand indicates that there is a balance of \$7,731.72 in the client trust account. Need clarification.</p> <p>2. **Opposition to Petition of Randall D. Coolidge and Tracie Coolidge-Fierro for Letters of Administration filed by Attorney Ryan M. Janisse on 05/23/2014** states that the decedent and Dianne E. Coolidge were married in the County of Mohave, State of Arizona, on 11/12/1993. They remained married until decedent's death on 02/18/2014. Decedent died in a tragic fire which consumed the Coolidge residence. The undisputed evidence before this Court is that Mrs. Coolidge is the surviving spouse of the decedent. Concurrently with the filing of this Opposition, Mrs. Coolidge has filed a competing Petition for Letters of Administration seeking her appointment as administrator.

The petitioners Randall D. Coolidge and Tracie Coolidge-Fierro are the decedent's estranged children. In their Petition, Randall and Tracie assert that Mrs. Coolidge is an "alleged spouse" and that decedent and she were never married. This is false.

Probate Code §8461 sets for the order of priority for appointment of an administrator of the state of a decedent as follows: "(a) Surviving Spouse...(b) Children...."

Because Mrs. Coolidge is the surviving spouse she is assigned priority to (a). Petitioners, as the decedent's children, are assigned to (b). Accordingly, the Petition for Letters of Administration filed by Mrs. Coolidge must be granted and the competing petition filed by Randall and Tracie must be Denied.

Therefore, Dianne E. Coolidge respectfully requests that this Court grant her Petition for Letters of Administration and deny the Petition for Letters of Administration filed by Randall and Tracie.
