Conservator's new attorney, Dean Hiyama, is in the process of purchasing Mr. Motsenbocker's business and has substituted in as attorney of record for the conservator. Mr. Hiyama's office is now in receipt of all documents necessary to prepare and file the second account, covering the period beginning March 1, 2013 through April 1, 2015.
