DOD: 12/17/1999		<p>PUBLIC ADMINISTRATOR, Successor Administrator appointed by Court on 10/4/2013, is Petitioner.</p> <p>Petitioner states:</p> <ul style="list-style-type: none"> • MARK COPPEDGE, son, was appointed personal representative on 4/10/2002, having listed in the petition that there existed in the estate \$57,500.00 in personal property; • On 10/4/2013, 11 ½ years later, Attorney DAVID SILVA reports to the Court that he has been unable to contact Mark Coppedge, and that the only asset was the house; • The Court removed Mark Coppedge [<i>per Minute Order dated 10/4/2013, Judge Hamilton</i>], appointed the Public Administrator as successor, and relieved Attorney Silva of further involvement in this matter; • Based on the representation that there was real property, the Public Administrator spent time researching, only to find that the Decedent had sold the real property to his son, Mark Coppedge, in 1990, 9 ½ years before the Decedent died; • Petitioner prepares this final report and petition for discharge of an insolvent estate 14 ½ years after the Decedent died; • Decedent left a Will dated 6/7/1988, disposing of property within the subject matter jurisdiction of this Court; however, there is no estate to distribute to the devisees; • It is unknown if notice was given to the Director of Health Services pursuant to Probate Code § 9202 or if the Decedent received Medi-Cal benefits; • There never were assets of the estate; the estate is in a condition to be closed; • No compensation is sought by Petitioner and Petitioner's Attorney; there is no estate from which to pay any Court fees or costs. <p>Petitioner prays that the final report be settled, allowed and approved, that all acts and proceedings of Petitioner as successor administrator be confirmed and approved, and that the Public Administrator be discharged as Administrator of the Estate.</p>	<p>NEEDS/PROBLEMS/ COMMENTS:</p> <p>Note: <i>Proof of Service by Mail</i> filed 5/22/2014 shows the Department of Health Care Services was mailed notice of this hearing on 5/22/2014, which appears to be a satisfactory attempt to rectify the lack of Petitioner's knowledge of whether notice was ever sent to the Department of Health at the inception of this estate or at any time thereafter.</p> <p>Note to Judge: For background on Attorney Silva's being relieved from further involvement, Mr. Silva's <i>Status Report</i> filed 9/27/2013 indicates not only his inability to contact Mark Coppedge, but also his having been declared ineligible to practice law by the State Bar. Mark Coppedge appears to have been deceased since 12/29/2011 per internet search.</p>

DOD: 04/18/04		<p>PUBLIC ADMINISTRATOR, successor administrator, is Petitioner.</p> <p>Decedent died intestate.</p> <p>No Creditor's Claims have been filed.</p> <p>Final I & A filed 09/26/03 indicated an estate value of \$130,000.00 consisting of real property (\$125,000.00) and personal property (\$5,000.00).</p> <p>Petitioner doesn't know what happened to the personal property. The real property was sold in December 2003 for \$127,600.00 by the former administrator.</p> <p>Petitioner states that there are no assets in their possession. Petitioner was appointed 10 years after the real property of the estate was sold. Petitioner found an address for the former administrator, Terri Brown, and sent a letter requesting that she call, but there has been no response. The Public Administrator does not expect to receive any assets, therefore the estate is in a condition to be closed.</p> <p>Terri Brown is the sole heir of the estate.</p> <p>Petitioner nor its attorney is requesting compensation for their services.</p> <p>Petitioner states that the former administrator and sole heir, Terri Brown, either gave away or kept the estate assets, including the sale proceeds of the real property. By doing so, and failing to account to this Court, she has breached her fiduciary duty. Therefore, she should be surcharged the full amount listed on the Inventory & Appraisal (\$130,000). Although there are no creditor's, attorney Gregory Roberts represented Ms. Brown and would be entitled to a statutory fee for his services. There is no estate to distribute to the devisees.</p> <p>Creditor's Claim of DHS filed 08/08/05 in the amount of \$260,350.10, dismissed 10/30/07.</p> <p>Inventory & Appraisal filed 07/29/05 listed property assets in the amount of \$145,000.00. Reappraisal in May 2007 listed the value at \$150,000.00. The real property was sold in August 2007 for \$85,000.00 by the former administrator. During this time period Adriana Brewer began helping care for the minor child. Once Ms. Smith got back on her feet she requested Adriana Brew to return the child to her however she refused and told her that the legal system was involved. This led Ms. Smith to make inquiries and discovering that there was a 04/08/2014 hearing regarding permanent guardianship over the child. To date Ms. Smith has not had the opportunity to read or review any documents in the court file because she resides in Los Angeles County. Ms. Smith respectfully requests that this Honorable Court deny the request for guardianship and order Adriana Brewer to immediately return custody of the minor to the mother. This will allow the child to be with her mother, the person who has her best interest, and her three siblings.

Additionally, if this Honorable Court is inclined to grant permanent guardianship of her daughter to Adriana Brewer, or any other person, Ms. Smith respectfully requests that this court continue the matter so that she may respond appropriately.

Declaration filed by Evoniesha Smith, Mother, on 04/07/2014 states Ms. Brewer has been a good temporary provider for the minor child, looking at her Facebook page reflects the love and reflects the selfishness motives of wanting to take the child away from Ms. Smith, mother. Ms. Smith states she went through a moment of despair and needed support. She thanks her for that. Ever since January 27th Ms. Smith has wanted to gain natural custody of her child back so she can raise her child.

Declaration also includes several documents including Facebook page photos, Verification of Benefits for the child, Money Order for the care of the minor child to Adriana Brewer, Immunization Records for the child.
