<b>DOD:5-12-13</b>	<p><b>ROSANNA TOROSIAN</b> was appointed Administrator with Limited IAEA on 8-6-13. Letters issued 8-30-13.</p> <p>At the hearing on 8-6-13, the Court set this status hearing for the filing of the first account or petition for final distribution.</p> <p><b>Status Report filed 10/01/14 states:</b> The beneficiaries of the estate are all non-residents of the United States and are represented by Stefano Abbasciano, Esq. of Walnut Creek, CA. The Administrator filed a Creditor's Claim with the Court on or about 11/26/13. An Objection to her creditor's claim was filed 02/19/14 by the heirs represented by attorney Abbasciano. A Mutual Compromise and Settlement Agreement has been agreed upon between Ms. Torosian and the heirs of the estate. - Objectors have filed a Petition for Probate of Will and Letters Testamentary, seeking admission of Decedent's Will dated 5/15/2007 to probate;
- Petitioners are named as co-executors under the will, and seek to commence administration of the estate;
- A *[Supplemental Declaration in Support of Petition for Probate of Will and for Letters Testamentary]* showing good cause was filed 6/11/2015 explaining the reasons for the delay in filing the petition for probate;
- **Supplemental Declaration states** good cause is demonstrated by (1) Decedent's estate presented several complex business and tax issues that the family had to consider prior to filing the petition for probate, and to determine the best overall approach; (2) fact-gathering was the first step, and establishing a methodology for collecting information regarding assets as to which assets were part of the probate estate, which are held in trusts, and which are community property or joint tenancy; (3) at all times since the Decedent's death, Petitioners (beneficiaries) were consulting with each other and were of like mind that they did not feel any need to immediately initiate probate proceedings until the issues were sorted out and carefully evaluated;
- As Decedent's sons, Petitioners have priority over the Public Administrator in administering their father's estate;
- Circumstances and general knowledge of which the Court may take judicial notice concerning recent staff changes in the Fresno County Public Administrators office further indicate that the Public Administrator is not the appropriate agency to administer the Decedent's estate;
- **It is respectfully requested that the Petition of Daniel L. Serimian and Leslie Morgan be denied, and that the Petition of David M. Serimian and Marlon D. Serimian for letters testamentary be granted; and that the Decedent's Will be admitted to probate [at hearing set for 7/20/2015].**
