DOD: 12/7/11	<p>KIRK HAGOPIAN was appointed as Administrator with Full IAEA authority and without bond on 7/26/12.</p> <p>Minute Order dated 7/26/12 set this status hearing for the filing of the inventory and appraisal.</p> <p>Inventory and Appraisal, partial no. One with a value of \$80,268.71 was filed on 5/31/13</p> <p>Status Report filed on 6/19/2013 states in summary, the Administrator not having any experience with the handling of decedent's estate sought the advice of his longtime trusted friend and fellow church member, Leroy Combs of Fresno. Mr. Combs said the Administrator should request help from Gaylene Bolanos (another church member, whom the Administrator has known since the 1190s) and from another acquaintance, Jeff Jackson. It is alleged that Bolanos appropriated the estate funds to herself, her father and a fictitious "foundation" she established. The Administrator has obtained a copy of falsified documents which Bolanos created and used to get possession of the estate assets. The Administrator hired Fresno Attorney Jeff Hammerschmidt and paid Mr. Hammerschmidt \$9,500.00 of his personal funds as the requested retainer. The Administrator and the attorney met with the District Attorney hoping to spur and investigation. To date, the District Attorney has apparently not investigated. After attending the meeting with the District Attorney, Mr. Hammerschmidt has apparently done nothing further to pursue the case he was retained to handle. - Petitioner does not have standing to file the petition. He is not a current beneficiary of the trust. The duty of a trustee applies to current beneficiaries. 16062(a).
- The trust was created by INNOCENZO and LAURA VENTRESCA, who have been the trustees of the trust since its inception. They have always been, and continue to be Trustees and the only beneficiaries of the trust.
- Janice Hunter was added as a trustee in 2004 and has been acting with Innocenzo and Laura Ventresca in that capacity since that time. Innocenzo and Laura Ventresca have not resigned nor become unable to act in the capacity of trustees. They do not wish to have the details of their trust disclosed to anyone.
- The trust does not provide that accountings be provided to remainder and/or contingent beneficiaries during the lives of Innocenzo and Laura Ventresca. Pursuant to Probate Code §15800, during the time that the trust is revocable, Innocenzo and Laura Ventresca, who hold the power to revoke the trust are competent, duties of the trustee(s) are owed only to Innocenzo and Laura Ventresca.
- Respondent was advised by Trustors Innocenzo and Laura Ventresca to deduct the cost of preparing this response, including legal fees and court costs, from the share, if any, that may be due Petitioner at such time as distributions take place in the future.
- Petitioner has been repeatedly advised, verbally and in writing, that he is not entitled to accounting. Because he receives income from Innocenzo and Laura Ventresca from time to time, Petitioner is under the mistaken belief that he is a current income beneficiary.
