He reported that they were uncooperative and explained that he had no right to any information after the date the decedent died. The only document they had was a tax return from the 1980's, which was long before the decedent died. The family provided names of two bookkeepers/accountants that had been reportedly assisting them with the business. One name was Judy Wiens. The PA has not be able to locate anyone by that name. The other was Roland Roos. MR. Status Report filed on 7/22/16 (cont.) According to the information provided to Ms. Kruthers, the business does not generate much income. In addition, the business was devised to the decedent's sons, Terry and Robin Tucker, so no other person has an interest in the business.

The decedent owned real property at the time of his death. According to a title search, the decedent's real property was sold by Terry Tucker as administrator of the estate. However, Mr. Tucker states that he signed papers for a short sale or foreclosure, and that he received no money. A notice of Proposed Action filed on 12/12/95 for the sale of the real property was signed by Mr. Tucker on 12/4/1995. The decedent devised the house to his wife, Laverne Tucker. The PA does not know if the proceeds were actually paid to Terry Tucker, and if so, why they are not available for distribution to Laverne.

The Public Administrator requests direction from the Court about continued administration of this estate.

DOD: 2/24/14		<p>RACHELLE IRELAND, Daughter, was appointed Executor with Full IAEA without bond on 4/16/15.</p> <p>At hearing on 4/16/15, the Court set this status hearing re filing the first account or final account.</p> <p>Status Report filed 3/22/16 states the decedent owned a one half interest in her residence on N. Callisch in Fresno with her partner, Gary Pritchard. The short sale completed 8/21/15 with no proceeds to the estate. The rental property in North Fork was listed for sale and recently the realtor Rusty Smith moved out of the North Fork area and unlisted the property without proper notification.</p> <p>The Executrix was in the process of finding another realtor when Chase Bank notified her and the tenants that they are starting foreclosure proceedings. The date of death appraised value is \$105,000. The mortgage is approx. \$83,000. The rental payments were going towards the monthly mortgage payments. The property taxes more than doubled in 2015-2016, which caused a significant rise in the monthly mortgage payment from \$626.36 to \$818.08. Rent is \$740, but Bass Lake Realty is the property manager who collects rent and handles day to day management, so after their pay, net rent received is \$666. The estate had previously raised the rent, but due to the dilapidated condition and many issues with the property, it cannot be raised any further.</p> <p>Because there were limited funds in the estate, it could no longer pay the shortfall and was forced to stop making the monthly mortgage payments in November 2015. The renters are currently still in the property and making their monthly payments. In the beginning of March, Chase Bank served notices of intent to start foreclosure proceedings. The attorney has been in contact with Jan Ramos, the property manager, and she has informed her that the tenants intend to stay as long as possible. It is to the estate's advantage to keep the tenants in the rental property as long as possible.</p> <p>The decedent also owned some minimal miscellaneous stocks that the estate is in the process of liquidating.</p> <p>The estate cannot close until foreclosure proceedings for the North Fork property have concluded. Therefore, further continuance of 90 days is requested.</p>	<p>NEEDS/PROBLEMS/COMMENTS:</p> <p>Note: On 6/29/16, there were no appearances and the Court set the OSC at Page B.</p> <p>Minute Order 3/23/16: The Court reviews a letter dated 2/23/16 from Trustee Corp. stating that the mortgage loan for the North Fork property was referred to their firm for foreclosure; the letter further states that parties may have alternatives available to avoid sale. Counsel represents that there is not enough funds in the estate to get the property out of foreclosure.
