Letters issued 7/17/14.</p> <p>At the hearing on 7/15/14, the Court set this status hearing re filing the first account or petition for final distribution.</p> <p><b>Status Report filed 4/20/16</b> incorporates the information set forth in the status report of 3/8/16 and further states: Attoreny Barbara A. Sena had several Workers' Compensation client cases which were pending at the time of her death. The Administrator notified the active clients of her passing and the cases have been transferred to the respective legal representatives accordingly. The Administrator has not acted as the legal representative for any of the decedent's clients.</p> <p>The Administrator has recently been advised that some of the workers' compensation client cases are nearing settlement, and therefore will pursue attorney liens on behalf of the estate once these cases have settled. These client cases, along with the federal and state tax liens and/or liabilities, must be resolved prior to preparation of a petition for final distribution.</p>	<p><b>NEEDS/PROBLEMS/COMMENTS:</b></p> <p><b>Minute Order 4/27/16:</b> Ms. Waite represents that she is waiting for the decedent's client cases to be resolved, which are being worked on by attorney Gary Hill. The Court orders that if the petition is not filed before 8/10/16, then both Ms. Waite and Mr. Hill are to file declarations that include information regarding all the remaining cases that have not yet settled at least two court days prior to 8/10/16.</p> <p><b>As of 8/5/16, nothing further has been filed.</b></p> <p><b>1.
