## 5 First Additional Page, Edward L. Myers, Jr. (Estate) Case No. 12CEPR01028

### Petitioner states:

- The Inventory and Appraisal was filed with the court on October 31, 2013; under Attachment No. 1, Item No. 1, petitioner claimed **\$40,000.00** as an announced distribution from the estate of decedent's father, Edward L. Myers, Sr., case No. 03CEPR00979 (Senior Estate);
- However, because Petitioner refused to sign a waiver of accounting in that estate, no distribution was ever made to Petitioner;
- Attachment No. 2, Item No. 1 of the Inventory and Appraisal contains decedent's personal residence [valued at \$170,000.00]; this asset is still in the estate and is used as a personal residence by Petitioner;
- Attachment No. 2, Item No. 2 to 4, describe an undivided one-third (1/3) interest in the assets distributed from the Senior Estate; Edward L. Myers, Sr., was the father of decedent herein, and he died on 4/5/2003; a partial distribution was made from that estate while decedent was still alive;
- However, that estate owned an interest in various parcels of real property subject to ground contamination; based on contamination concerns, the Senior Estate created a Limited Liability Company to manage the property until it could be sold to a third party; this eventually turned out to be a lengthy endeavor; distribution of the Senior Estate was not resolved until a hearing on 2/22/2016, when this Court approved a petition to distribute;
- The Estate of Edward L. Myers, Jr. was named as a beneficiary of Senior Estate in the amount of **\$90,768.50**, and that amount was placed in the estate account.

### Distribution pursuant to intestate succession and Agreement on Division of Intestate Shares dated 10/18/2012, attached as Exhibit K to the First and Final Account filed on 7/25/2016, is to:

**DAWNETTE MYERS** – Need amended proposed distribution;

**MARTHA PHILLIPS** – Need amended proposed distribution.

### NEEDS/PROBLEMS/COMMENTS, continued:

1. The instant *First and Final Account* states "the only remaining asset involves the future one-third payment of reserve funds in the Senior Estate" [Case 03CEPR00979.] It appears the instant estate is not yet in a condition to be closed due to anticipated receipt of further assets. Further, the *Estate of Edward L. Myers, Sr.*, Case 03CEPR00979, per *Order Settling Final Report of Administrator with Will Annexed, etc.*, filed 3/24/2016, ordered distribution to **DAWNETTE MYERS**, Administrator of the *Estate of Edward L. Myers, Jr.*, the cash sum of **\$90,768.50**, which distribution is evidenced by *Distributive Receipt* signed by Petitioner Dawnette Myers and filed **4/18/2016** in Case 03CEPR00979. The instant account period ends **4/5/2016**, as indicated on the *Summary of Account*. Need amended accounting for the entire period of administration of assets, which includes the distribution of **\$90,768.50** receipted for by Petitioner on 4/18/2016, that should be accounted for as a Receipt on an amended *Summary of Account*, and which includes any 1/3 payment of the **\$15,000.00** closing reserve funds from the *Estate of Edward L. Myers, Sr.*, Case 03CEPR00979.
2. *Final Inventory and Appraisal* filed 10/31/2013 shows on *Attachment 1*: "Cash Distribution from estate of Edward L. Myers, Sr., **\$40,000.00**." Paragraph 11 of the petition states: "Petitioner claimed **\$40,000.00** as an announced distribution from the estate of decedent's father, Edward L. Myers, Sr., case No. 03CEPR00979. However, because Petitioner refused to sign a waiver of accounting in that estate, no distribution was ever made to Petitioner." Need further explanation as to existence of the undistributed **\$40,000.00** cash to the *Estate of Edward L. Myers, Jr.* as stated by Petitioner.

**NEEDS/PROBLEMS/COMMENTS, continued:**

3. The *Distributive Receipt* signed by Petitioner Dawnette Myers on 2/24/2016 and filed 3/4/2016 in Case 03CEPR00979, states the Petitioner as the sole surviving Co-Administrator of the Estate (the deceased Co-Administrator, Edward L. Myers, Jr., is the instant Decedent) received pursuant to *Judgment of Preliminary Distribution* on 6/2/2005 from the *Estate of Edward L. Myers, Sr.*, the following assets totaling **\$85,178.23**: Cash of **\$59,291.06**; Pacific Mutual Life Insurance Policy with value carried at **\$6,405.00**; and  $\frac{1}{4}$  interest in Promissory Note dated 7/3/2001, with the value of the  $\frac{1}{4}$  interest stated as **\$19,482.17** in the unpaid balance, all distributed to Petitioner as Administrator of the *Estate of Edward L. Myers, Jr.* However, the *Final Inventory and Appraisal* filed 10/31/2013 does not reflect any of these assets indicated as received by Petitioner. Need clarification and a corrected or supplemental Inventory and Appraisal to be filed with the Court as part of the accounting.
4. Capital One Creditor's Claim listed in paragraph 29 of the petition is stated as **\$4,958.18**; however, the correct amount of the Claim filed 3/5/2013 is **\$4,953.18**.
5. Need revised proposed order based upon an amended accounting that contains revised proposed distribution, corrected or supplemental inventory and appraisal, and an accounting for receipts that have come into the estate, as well as for receipt of any future reserve assets from the *Estate of Edward L. Myers, Sr.*

	<b>Petitioner states</b> On 10/7/12, David J. St. Louis, a member of the State Bar of California, passed away leaving unfinished client matters, including funds in his attorney client trust accounts.		
	On 9/6/13, Joan St. Louis requested the Court assume control over the law practice of her deceased husband pursuant to Probate Code §9764 and Business and Professions Code §6180 et seq.		
	On 3/26/14, the Court assumed control over the Law Practice of David J. St. Louis and appointed attorney Paul T. Chambers to assist the Court in winding up and concluding the legal and financial affairs of Mr. St. Louis. Mr. Chambers posted bond of \$47,000 on 3/17/14. Mr. Chambers was authorized to, among other things, take possession and control of any and all bank and/or financial accounts relating to the David J. St. Louis law practice, including the client trust account held at Bank of the West and the bank account held by Mr. St. Louis at Fresno First Bank fbo John K. Shirin or his heirs.		
	In addition, as part of the court order dated 3/26/14, the court approved payment of \$40,986.20 to Bianca Soria and \$1,904.43 to Walter Wentz from Mr. St. Louis' client trust account. Evidence of payments was presented with Mr. Chambers' first account.		
	On 5/24/14, Hon. Robert H. Oliver amended the 3/26/14 order to allow Mr. Chambers to transfer funds from the Fresno First account to Bruce Bickel as trustee of the John K. Shirin Testamentary Trust. **Petitioner states** Mr. Chambers filed his First Account of IOLTA Trust Funds on 10/30/14, which was approved on 2/3/15. The Court ordered payments be made as set forth in the order. Attached as Exhibit A is evidence of payment in the amounts ordered, except that the amount ordered paid to Christina Fierro was paid to the Phia Group due to a lien (see Declaration of David A. Roberts for details).

Accordingly, after the checks cleared, the balance at Bank of the West was zero. Both accounts are now closed.

Petitioner states all outstanding bills of the law practice had been paid prior to Mr. Chambers' appointment, and Mr. Chambers found that no funds were owed to Mr. St. Louis as a result of his activities as an attorney. All open files were cases dealing with medical malpractice or other types of personal injury which had been taken on a contingency basis. Mr. St. Louis had partnered with attorney Timothy McGill to handle these cases. All of those cases have been turned over to Mr. Magill in their entirety and Mr. Magill and Joan St. Louis, as the personal representative and sole heir and beneficiary of the estate of David St. Louis and his law practice, have agreed on a division of any contingency fund obtained from those cases.

All active files of attorney David J. St. Louis known to have existed at his death have been referred to and accepted by competent counsel. There is nothing further to be done to wind up the affairs and close the law practice of David J. St. Louis and accordingly the practice administrator Robert Koligian, Jr., should be discharged of his duties.

**Petitioner prays for an order approving the Second and Final Account and Report of Law Practice Administrator; for an order discharging the practice administrator; and for such other and further relief as the Court deems just and proper.**
