**Response and Objections to Petition for Instructions Regarding Validity of Trust Documents filed by Janice N. Hunter, Louise Marie Ventresca and Mary Ventresca Prout, Trustees of the Ventresca Family Trust on 8/25/16.** Objectors state they are the current Trustees of THE VENTRESCA FAMILY TRUST, Dated April 30, 1997, as amended ("Trust")

INNOCENZO N. VENTRESCA and LAURA M. VENTRESCA, as settlors, established the Trust. The First Amendment to the Trust is dated September 23, 1998. The Second Amendment to the Trust is dated February 25, 2004. The Third Amendment to the Trust is dated October 20, 2006 and the Fourth Amendment to the Trust is dated May 25, 2010.

Petitioner questions the validity of the 2006 Amendment to the Trust which eliminated Petitioner as a Trust beneficiary. However, the 2006 Amendment was cancelled and superseded by the 2010 Amendment which reinstates Petitioner as a beneficiary as to half of the share which he would have received under the original Trust document, with the other half of Petitioner's original share passing to his son.

Petitioner's unverified Petition asks the court for instructions regarding the validity of the 2006 Amendment. As noted above, this Amendment was cancelled by the Settlers and has been superseded, and although it was valid when signed, its alleged invalidity does not affect Trust distribution. The Petition also requests the Court instruct the Trustee of the Trust to gather information from Dr. A. Paul Mello regarding the correspondence attached to the Petition in connection with the competency of the Settlers. As set forth below, Respondents have already obtained this information.

Respondent's deny that Settlers "did not know what they were doing" when they signed the 2006 Amendment. Respondents are informed and believe that Settlers made changes in the 2006 Amendment to their Trust regarding the share of Petitioner because Settlers disapproved of Petitioner's lifestyle and choices.

With respect to Petitioner's request that the Trustees gather information regarding the October, 2006 correspondence signed by Dr. Mello, Respondents allege as follows: Based on the suggestion of Settlers' attorney, Joanne Sanoian, Respondent, JANICE N. HUNTER in October 2006 asked Settlor's physician, A. Paul Mello, M.D., if he would provide a letter regarding Settlers' competency. Dr. Mello said that he would do so and, as authorized by Dr. Mello's assistant Dixie, Respondent, JANICE N. HUNTER, typed the October 24, 2006 letter which Dr. Mello signed. After signing a July 19, 2016 letter indicating the October, 2006 letter did not original form his office and appeared fraudulent, Dr. Mello has further reviewed his files and has provided to Respondent's attorney a Declaration (attached as Exhibit F) stating Dr. Mello now believes the 2006 letter was not fraudulently obtained. More significantly, Dr. Mello has reiterated in his attached Declaration that the statements in the 2006 letter were accurate including the statement that: "It is my medical opinion that MR. and Mrs. Ventresca are medically competent to make financial decisions, manage their financial affairs and execute estate planning documents."

If Petitioner proceeds with his Petition, Respondents request that the Court require that the Petition be verified.
