<b>DOD: 3/12/2010</b>	<p><b>GORDON PANZAK</b>, son, filed his <i>Beneficiary and 2nd Successor Trustee Gordon Panzak's Petition to Remove 3rd Successor Trustee (Public Administrator)</i> on 1/28/2015, which was set for hearing on 3/16/2015.</p> <p><b>PUBLIC ADMINISTRATOR</b> had previously been Court-appointed as Successor Trustee on 4/29/2013.</p> <p><b>Minute Order dated 3/16/2015</b> [Judge Conklin] from the hearing on the <i>Petition to Remove 3rd Successor Trustee</i> states <b>PUBLIC ADMINISTRATOR</b> voluntarily resigns as successor trustee and has no objection to <b>GORDON PANZAK</b> being appointed as successor trustee. Petitioner will not file an order for the Court's signature; instead, counsel indicates this Minute Order will suffice. Court sets a status hearing six months out at counsel's request.
