Letters were issues on 05/13/92.</p> <p>Inventory &amp; Appraisal filed 02/23/94 - \$107,198.00</p> <p><b>Minute Order from hearing on 06/30/10</b> states: the court orders Danece Hamilton removed as personal representative of the estate, proper notice having been given. The court appoints the Public Administrator forthwith. Letters are to issue from the Minute Order.</p> <p><b>Letters of Administration</b> were issued to the Public Administrator on 07/27/10.</p> <p><b>Notice of Lien</b> was filed 02/13/15.</p> <p><b>Notice of Status Hearing</b> filed 03/09/15 set this matter for a status hearing re Failure to File First Account and Petition for Distribution.</p> <p><b>Status Report Regarding Estate Assets</b> filed 10/27/15 states: The decedent's wife (and former administrator) Danece Hamilton, has been residing at the residence located in Tollhouse, CA. The property taxes had not been paid and the Public Administrator filed an Unlawful Detainer action to have her evicted so they could sell the property and pay the taxes owed. However, Ms. Hamilton made arrangements to pay the taxes, and she has stated that she would like to pay the costs of administration of the estate, so that she can keep the home. More time is necessary to work that out with her.
