Petitioner states that the Guardian and minor both reside in Santa Cruz County and the biological mother, Heather Huffman, resides in Monterey County. Petitioner is employed as a doula, providing services and support to women during childbirth. As part of her job, she is on call and must immediately attend to her clients when they go into labor. Petitioner is also a mother and the care provider for her own children in addition to the minor.</p> <p><b>Petitioner states</b> that it is a burden to take time off of work to travel to Fresno to attend hearings in this case. The travel time requires Petitioner to have to make other arrangements to ensure that all of the children under her care are fed and make it to school in a timely manner. This burden would be significantly lessened if the proceedings were moved to Santa Cruz County. Wallen. It is unclear what negotiations have occurred since then, but the Public Administrator believes Mr. Wright has had difficulty obtaining a loan. On 07/06/15, an extension of time was signed giving them until 12/31/15 to complete the sale. The Public Administrator believes that Mr. Wright has been paying the mortgage payments and property taxes on the property. Deputy Scott Stacey placed a call to Mr. Wright in an attempt to determine whether he will be proceeding with the purchase of the property. Mr. Wright was not available and a message was left. If Mr. Wright and his wife cannot complete the purchase, they will either have to vacate the property so it can be sold or they will have to make the property available for listing and showing for sale while continuing to make the mortgage payments and paying the property taxes. It is requested that the next status hearing be set no sooner than 4 months from the date of this hearing.</p>

The above information was taken into consideration when determining the initial asking price, which was set at \$1,300,000 for the entire parcel, or \$650,000 for the estate share. Basically, the amount was determined by taking 90% of the date of death value plus \$250,000 to cover provisions in the agreement described above.

Executor and Cindy Gill believed \$1,000,000-1,200,000 was an obtainable goal. New information and market conditions led us to believe this price is now too high.

There have been three offers to date. Counter offers on all three were made for slightly over \$1,000,000 based on a 10% reduction from the date of death appraised value. None was accepted.

It has now come to Executor's attention that developers are concerned with potential development restrictions imposed because of Dog Creek and Gould Canal that may hinder the number of potential development sites on the property. The Army Corps of Engineers and Fresno County Flood Control District have been contacted to assist in analysis of these restrictions.

Ms. Laura Mather of London Properties has now been engaged to assist in the sale. Both owners are encouraged by her efforts and are hopeful that she will lead to a successful conclusion of the matter. Attorney Hemb plans to have Ms. Mather attend the hearing on 9/14 to provide an opportunity to the Court to raise any questions it may have regarding current market conditions.

Executor is doing everything possible to sell the decedent's interest in the property. As sole beneficiary, Executor has no reason to delay administration. It is her goal to bring this matter to a successful conclusion as soon as possible.
