TREVINO</p> <p>Paternal grandfather: FRANK TREVINO Paternal grandmother: JOANN TREVINO (biological) - GLORIA ESCOBAR (step-grandmother)</p> <p>Maternal grandfather: LEONARD C. AGUILAR, JR.</p> <p>Petitioner states that the father is in prison in Texas and the mother is not stable and unfit to care for Sariah. Petitioner states that CPS has been involved due to personal problems of the mother and paternal grandmother.</p> <p>Declaration of Gloria Escobar filed 12/14/11 attaches an order dated 12/09/11 from Harris County Texas in which Gloria Escobar was granted custody of Sariah and Leann Trevino was granted supervised visitation. Also attached is a child support contempt order dated 12/08/11 for failure of Leann Trevino to pay child support to Gloria Escobar, a filed but not signed by the court, Temporary Restraining Order filed by Gloria Escobar against Leann Trevino filed 11/17/11 in Harris County Court, Instant Motion and Order on Instant Motion for Drug Testing on Leann Trevino filed by Gloria Escobar on 12/08/11, but not signed by the Court, a waiver of service signed by Sariah's father, Jaime Trevino, a Power of Attorney signed by Jaime Trevino appointing Gloria Escobar as Power of Attorney on his behalf, and a letter from Jaime Trevino to the Harris County Texas judge requesting that Gloria Escobar be granted custody of Sariah. Further, a copy of an application for order and supporting declaration in the Fresno County divorce proceeding (in 2002) between Petitioner Marianita Aguilar and maternal grandfather, Leonard Aguilar, Jr. in which Mr. Aguilar states that the maternal great grandmother was physically and verbally abusive to their children. (Petitioner is currently living with her parents in Sanger.)</p>	<p>NEEDS/PROBLEMS/COMMENTS:</p> <ol style="list-style-type: none"> 1. Need Notice of Hearing. 2. A declaration of due diligence filed 12/08/11 states that the father is in prison in Texas and the mother's current whereabouts are unknown.
