This is a continuation from the October 20, 2021, hearing on moving party's application for Kane St. John to appear *pro hac vice* on behalf of plaintiffs. In the October 20, 2021, adopted tentative ruling, the court listed several defects that required correction and continued the hearing for the defects to be corrected.
