Temporary Guardianship of the Estate or Person and Estate Packet

The forms in this packet may be used to request or petition the Court for a temporary guardianship of an estate or a temporary guardian of a person and estate. These forms must be filed in conjunction with the corresponding petition.

To Petition for Temporary Guardianship of the Estate or Person and Estate:

- · Complete <u>all</u> of the Mandatory Forms included in this packet <u>in addition to</u> all of the Mandatory Forms in the <u>Guardianship of the Person Packet</u>.
- · Once you have completed and reviewed the packet, make two (2) photocopies of all documents (every page), staple each document separately. Place the copies of each document in order behind the corresponding original.
- · Bring the completed originals from both packets (Temporary Guardianship of the Person and Guardianship of the Person) and two (2) photocopies to the Probate Clerk's Office at the B.F. Sisk Courthouse, 3rd Floor
- · The Probate Clerk will file your originals, once filed, your copy will have the case number and hearing date filled in.
- · Someone over 18 years of age and not party to the case (not you) must personally serve or hand-deliver a copy of the Petition, all of the attachments, a Notice of Hearing and the Comparison of Guardians with Other Nonparent Caregivers (GC-207) to the parents and to the child if they are age 12 or older.
- · You will also need to have all grandparents and any siblings of the child that are age 12 or older served with copies. They can be served by mail.
- · Service must be completed at least 5 days before your hearing date, if a hearing is set by the Court.
- · The person who serves the documents for you must fill out and sign the proof of service on the Notice of Hearing. Then bring the Notice of Hearing back to the Probate Clerk's Office with the proof(s) filled out. This must be filed before your hearing date.

The forms may be printed out as blank forms and filled in by typewriter, or may be filled out online and printed out ready for signature and filling.
