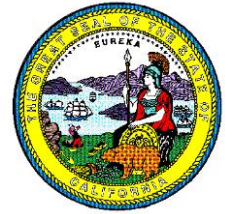

RE: Fresno Superior Court Temporary Closures and Consolidation of Services during November 21, 2022 through November 23, 2022

On November 21, 22, and 23, 2022, the Fresno Superior Court will temporarily consolidate cases and all essential hearings to be heard only in the Main Courthouse and the Juvenile Justice Courthouse. In addition, all Clerks' Offices will remain closed, with the exception of the criminal walk-up windows located at the Main Courthouse, B-1 Level. Courthouse status will be as follows:

Clerks' Office services will be unavailable on the above dates. All court filings are required to be submitted via e-filing or drop box. Drop boxes will be located as follows:

- JUVENILE DEPENDENCY: Main Courthouse, 1100 Van Ness Avenue, Main Entrance
- CIVIL/FAMILY/PROBATE: B. F. Sisk Courthouse, 1130 "O" Street, Main Entrance
- Self-Help Center and Archives Department services will be unavailable.

During Court Temporary Closures and Consolidation of Services, Judge Brian Alvarez will be the Acting Presiding Judge. If an Emergency Protective Order (EPO), felony arrest warrant or search warrant needs to be signed, those matters will go through Master Calendar.
