#### **Tentative Ruling:**

To deny. (Code Civ. Proc., § 2033.280.)

## **Explanation:**

When a party fails to respond to requests for admissions, the proper motion is for deemed admissions, not to compel a response. (See Code Civ. Proc., § 2033.280, subd. (b).) Here plaintiff moves "For an Order to Compel Defendant, DAVID OWEN JR. ZARUCCHI (hereinafter 'Defendant') to answer (respond without objections) the Request for Admission, Set Three, served on May 15, 2025, within 10 days of the Court's ruling on this motion to compel" and for sanctions. (See Notice of Motion.) Because plaintiff requests relief for which there is no statutory basis, the motion is denied.

The court also notes that plaintiff requests \$1,000 in monetary sanctions without providing the court any information about the attorney fees incurred in making the motion. (See Fanucchi Decl., \$9\$ 6.) This would not have been granted, even if plaintiff filed a viable motion.

Pursuant to California Rules of Court, rule 3.1312(a), and Code of Civil Procedure section 1019.5, subdivision (a), no further written order is necessary.
