At 11:26 a.m., cassette tape #2, (4/9/04 interview of Gypsey Wesson) - People exhibit #700B is played.

Court admonishes the jury and recesses at 12:00 p.m. Outside the presence of the jury, Court and counsel discuss scheduling issues and time lines for the exhibit's.
