These are the cables needed in order to connect to the attorney's desk Audio Visual (AV) monuments in the courtrooms.

## 2nd Floor (Family Law) and 3rd Floor (Probate) Courtrooms



Attorney will need to contact the court reporter for this item.



### 3 Ft. 3.5mm Male/Male Stereo Audio Cable

Connect the 3.5mm jack from your notebook/netbook to the Court's 3.5mm audio jack to play your audio on the courtroom speakers.



### 6 Ft. HD 15 SVGA/SXGA/UXGA Male/Female Monitor Extension Cable

Connect your notebook/netbook/tablet to the Court's projector VGA cable to display what is on your screen on the Court's projectors in the 2nd and 3rd floor courtrooms.



### Elmo P10 Digital Visual Presenter

The Elmo P10 will allow you to display 2D and 3D objects in great detail. The jog dial will allow you to focus in on intricate details of your object with 16X optical zoom and 8X digital zoom that enlarges the image up to 128X on the Court's projectors.

### InFocus IN2114 DLP Projector

The InFocus projector will display an image from the Elmo P10, JVC DVD Player, and your notebook/netbook onto a portable projector screen in the courtroom.

### JVC DVD Player

The DVD player will allow you to play video from a DVD disc or audio from a CD disc. In order for your video to display correctly on the DVD player, all video must be in DVD format and burned to a DVD-R type disc. In order for your audio CD to work on the DVD player, all audio files must be saved as .mp3 or .wma format and burned to a CD-R type disc.

## 4th Floor (Civil) and 5th Floor (Civil) Courtrooms



Attorney will need to contact the court reporter for this item.



### 3 Ft. Composite Video RCA Male/Male (Yellow) Cable

Connect composite video cable from your camcorder to the Court's composite video jack to display your video on the 4th floor video system in the courtrooms.

### 3 Ft. 3.5mm Male/Male Stereo Audio Cable

Connect the 3.5mm jack from your notebook/netbook to the Court's 3.5mm. audio jack to play your audio on the courtroom speakers.



### 3 Ft. HD 15 SVGA/SXGA/UXGA Male/Male Monitor Cable

Connect your notebook/netbook/tablet to the Court's VGA jack (computer in) to display what is on your screen to the video system in the 4th and 5th floor courtrooms. The ideal resolution for your electronic device to display effectively on the 4th floor courtroom LCDs is **1024 x 768**.
